

LOCAL LIQUOR OPTION ELECTION PETITION

Revised Code Sections 3501.38, 3501.382, 3503.06, 4301.323, 4301.333 and 4301.355

A petition to submit the question of the sale of beer, wine and mixed beverages or spirituous liquor at a particular location within a precinct if the petitioner for the local option election is an applicant for the issuance or transfer of a liquor permit at, or to, a particular location within the precinct; or the holder of a permit at a particular location within the precinct; or a person who operates or seeks to operate a liquor agency store at a particular location within the precinct; or the designated agent of one of these persons.

INSTRUCTIONS

1. Either or both of the two questions set forth below may be submitted.
2. The petition section for any question to be submitted must be completed **before** any signature may be obtained on this petition.
3. The petition must be filed with the County Board of Elections wherein such precinct is located, not later than 4 p.m. of the 90th day before the day of a General or Primary Election, except as follows:
 If the petition is being filed with respect to a previous local option election, the petitioner must satisfy both of the following conditions:
 - a) No later than 29 days after the Ohio Division of Liquor Control receives final notice of the result of such election affecting the liquor permit holder, the petition must be filed with the County Board of Elections where such precinct is located; **and**
 - b) No later than 29 days after the Ohio Division of Liquor Control receives final notice of the result of such election affecting the liquor permit holder, a copy of the petition with the board of elections file stamp must be filed with the Superintendent of the Division of Liquor Control.
