

LOCAL LIQUOR OPTION ELECTION PETITION

Revised Code Sections 3501.38, 4301.324, 4301.334 and 4301.356

A petition to submit the question of the sale of beer and intoxicating liquor on days of the week other than Sunday and between the hours of ten a.m. and midnight or eleven a.m. and midnight on Sunday at a community facility or a community entertainment district.

INSTRUCTIONS

1. Before obtaining signatures, complete the name, address of the community facility, and if applicable, the boundaries of the community entertainment district.
2. The petition must be filed with the Board of Elections of the county wherein such facility is located, no later than 4 p.m. of the 90th day before the day of a General Election.
